CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 2) ORDER 2015

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 2) Order 2015**.

(2) This Order comes into operation on 1 March 2015.

Amendment of Fourth Schedule

2. The Customs (Prohibition of Imports) Order 2012 [P.U. (A) 490/2012] is amended in Part II of the Fourth Schedule by inserting after item 10 and the particulars relating to it the following item:
